**From the north/west** take Interstate I290 East, exit Lake St. to York Rd., make a right to Industrial Dr.

### **IMPORTANT!!**

**If you have not previously passed a PT or ORT for the odor you wish to trial in & plan to enter both the PT & full trials for the same day, per UKC rules, you CANNOT compete in the full trials that day if you do not pass the PT for that odor.** As this is a pre-entry only trial (we must refuse additional entries once we are full), we cannot refund entry fees on the day of the trial for dogs that are unable to compete due to not passing the Pretrial for that odor.

### Entry Fees:

Pre-Entries: PT: \$15 per odor/IE: \$20 per element/Full trial: \$100 per trial

DOS: PT: \$20 per odor/IE: \$25 per element/Full trial: \$110 per trial

1. Nosework trials will include a pre-trial for the levels being run. Dogs need to pass the pre-trial for the level they are competing in. Dogs may be entered prior to passing, but must pass the pre-trial prior to competing that day. If the dog has passed on ORT in the applicable odor please submit a copy of proof.
2. Individual element classes are divided into Levels "N" - "E" and further divided into "A" and "B" sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching the elements chosen.
3. Full Nosework Trials are divided into Levels "N" - "E" and further divided into "A" and "B" sections depending on the experience of the dog and/or handler. These trials contain all four elements. Each element passed earns a leg toward a title in that element.
4. Handler Discrimination. One glove will be used and must be provided by the handler.
5. All entries must be submitted on the current "Official UKC® Nosework Trial Entry Form".
6. Use a separate entry form for each dog entered in a club's event.
7. Nosework events are open to all UKC registered breeds and mixed-breed dogs with a valid Performance Listing/Limited Privilege number/Permanent Registration/Temporary Listing.
8. We want you to keep the points earned at UKC Licensed events. Important things to remember:
  - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.
  - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at [www.ukcdogs.com](http://www.ukcdogs.com) or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
  - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
