### Directions to Trial Site:

**From the south/east** take Interstate I290 West, exit York Rd., make a left on York Rd. to Industrial Dr., make a left on Industrial Dr.

**From the north/west** take Interstate I290 East, exit Lake St. to York Rd., make a right to Industrial Dr.

### **IMPORTANT!!**

**If you have not previously passed a PT or ORT for the odor you wish to trial in & plan to enter both the PT & IE trials for the same day, per UKC rules, you CANNOT compete in the element trials that day if you do not pass the PT for that odor.** As this is a pre-entry only trial (we must refuse additional entries once we are full), we cannot refund entry fees on the day of the trial for dogs that are unable to compete in the Element trials that day due to not passing the Pretrial for that odor.

### Entry Fees:

Pre-Entries: PT: \$15 per odor/IE: \$20 per element  
DOS: PT: \$20 per odor/IE: \$25 per element

**For those with multiple dogs, exhibitors may handle only one dog per element level per trial. For example, you may run one dog in novice Containers, and another in advance Containers, but the same handler cannot run 2 dogs in novice. Entries will be returned with 2 or more dogs entered in the same class.**
