You will need the following information for registration:

Name, address, phone, email, Dog's Call Name, Rat Games Number Dog's Date of Birth, Breed, Sex. You select which games you wish to enter and sign the Certificate of Agreement and Liability Waiver.

Notice to Exhibitors

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children, and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of DSA, be asked to leave the trial site. In such case, no refund on any entry will be made.

Venue: Trials will be held in an indoor, heated facility on a matted surface with a tarp. There is crating space indoors. You may also crate in your vehicle. No Ex-Pens are permitted on the mats. All crates must have a protective cover underneath them.

Dogs

All dogs must be on leash and under control while on trial grounds except while showing. **FLEXI LEASHES ARE NOT PERMITTED at the show site.**

Please pick up after your dog and dispose of waste in appropriate containers.

Electric collars ARE NOT PERMITTED at the show site.

Bitches in season MAY compete in Rat Games. They will be run at the end of each class. Bitches in season must wear pants. If bringing a bitch in season, please inform the trial secretary prior to the trial, and inform all exhibitors at the judge's briefing. A separate potty area will be provided. Disruptive dogs will have to be crated separately.

Please clean up after yourself.

NOTICE: WE HAVE A DESIGNATED AREA FOR POTTING YOUR DOG. ANY EXHIBITORS FAILING TO USE THE DESIGNATED AREA COULD BE ASKED TO LEAVE THE GROUNDS, NO REFUNDS GIVEN.

NO SMOKING OR VAPING in this facility or on the grounds. You may smoke in your vehicle only and dispose of butts in your vehicle as well.

COVID-19

I/we certify that I/we do not, to my/our knowledge, have COVID-19 at the time of attending this trial. Nor have I/we been in contact with or exposed to any known carrier of COVID-19 within the past 14 days. If I/we have been diagnosed with the virus or have had virus-like symptoms but no formal diagnosis, I/we certify that we have been released by government officials and/or my/our health care providers to resume all activity with no limit and can produce results from a positive antibody test on request or have had no symptoms for a minimum of 14 days prior to the Trial. I/we understand that we have entered and are competing at this Rat Games Trial entirely at my/our own risk and take full responsibility for my/our own health and safety during this Trial. I/we pledge to follow all Rat Games and specific Club Trial rules and requirements to mitigate any possibility of infecting others or becoming infected. In such case, no refund on any entries will be made.

You are responsible for reading the Rat Games Rules for competitors. Rules can be obtained online at www.ratgames.com. Dogs are required to have a Rat Games number to show in a Rat Games trial.

No electronic collars, no head halters, no Flexi/retractable leashes on trial grounds. Do not tie dogs or leave dogs unattended. Dogs are not allowed to run free on grounds. Any dog deemed aggressive by **judge or trial committee may be excused and no refund will be given.**

CANCELLATIONS AND REFUNDS:

For cancellation of entries more than 5 days before the game will receive a full refund minus \$10 processing fee. For cancellation of entries received less than 5 days before the game, no refunds will be issued unless a replacement entry is available from the wait list, and there will be a \$10 processing fee. Entry fees shall not be refunded in the event that a dog is absent, disqualified or excused by the Rat Games official or judge.

Refunds are available for injured or deceased with proof of injury or death.

No part of the fee will be refunded if the trial cannot take place or be completed by reason of fire, civil disturbances, an Act of God, public

emergency, or any other cause beyond the control of the trial organizers.

A \$25 collection fee will be added to each returned check.

Up to 5 dogs in a blind, blind will be a 20'x10' tent without dividers.
