DIRECTIONS TO TRIAL SITE:

From the south/east take Interstate I290 West, exit York Rd., make a left on York Rd. to Industrial Dr., make a left on Industrial Dr.

From the north/west take Interstate I290 East, exit Lake St. to York Rd., make a right to Industrial Dr.

All dogs must be on leash and under control while on trial grounds. Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs **MUST** run "naked," without a collar/harness. Collars/harnesses which can be easily and quickly removed and replaced are strongly encouraged. NO flexi-leads allowed.

It is also advisable to bring a crate or x-pen for your dog during times they may need to be left attended. Humans are welcome to observe working dogs; however, dogs may not be within 20' of the rings when dogs are working.

Dog exercise areas will be marked, please pick up after your dog and dispose of waste in appropriate containers outside the building

All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. No entries will be taken over the phone or electronically. Make check payable FOR YOUR K9. Send entries & fees to the trial secretary.

These trials will be held indoors in a heated/cooled facility.

Please be considerate about picking up after your dogs and leaving the grounds as you find them. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement per BHA regulations.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run in panties at the end of their class/trial.

If bringing a bitch in season, please inform the trial committee prior to the trial, and you must inform all exhibitors at the judge's briefing.

Loud/Disruptive dogs

Dogs that are loud and disruptive may be asked to be located away from the rings/crating area. Dogs/handlers who are so disruptive in the blind that they disturb other dogs to the extent that the other dog's performance will be adversely affected are dismissed from the blind by a Trial official and/or the Judge of Record. If the dog cannot be brought under control, the dog may be dismissed from the class and/or Trial/Event.

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee. Terrier sparring is not allowed on trial grounds.

Please always be mindful of your dog and do not allow your dog to approach other dogs uninvited. All dogs are expected to always be under handler's control. If there are times when you cannot monitor your dog, please crate him.

Any dog that is sick, injured or lame will be excused from the trial grounds.

Refunds

Entry fees will not be refunded if a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
